The Mission provides a long-term residential program for female victims of domestic violence and their children by providing a safe place where women can find healing and regain independence. The goal with this long-term program is to empower these women to become self-sufficient by gaining self-esteem, life skills, and Biblical knowledge, and they are taught to recognize and break the cycle of violence.
